RE: Scholarships for the DEHUKAM Master (LLM) Program in the Sea and Maritime Law (2020-2021)

Ankara University Research Center of the Sea and Maritime Law (DEHUKAM), as a research center founded as a result of the Recommendation by the Republic of Turkey's Ministry of Foreign Affairs, supports academic and scientific research, education, and discussion on the sea and maritime law and policy issues. In its field, DEHUKAM is the key research institution in Turkey. Some of its core aims are to: unify all Turkish academics under one roof; encourage academic and interdisciplinary interaction at all levels; address international; regional and local issues; organize LLM program and international workshops within this area.

DEHUKAM has initiated "The Master's Program in the Sea and Maritime Law" from the Fall Semester of 2018 with the participation of foreign lecturers. The Program includes more than thirty lectures specialized in mainly three major topics in this field: (i) the Law of the Sea, (ii) Maritime Law, and (iii) Maritime Security Law. Lecturers who will give courses in the program will be from Turkey as well as foreign countries and each lecturer is a specialist on his/her academic field and an expert on a practical level.

Türkiye Scholarships:

"Türkiye Scholarships Program" offers scholarships to international students from all over the world to study in Turkey.

Türkiye Scholarships applications for 2020 will be received in one period, and applications will be open between **10th January - 20th February 2020** for international students from all countries.

The Postgraduate Scholarship Program covers:

- University and program placement;
- Monthly Stipend: 1100 TL per month;
- Tuition Fees;
- Once-off Return Flight Ticket;
- Health Insurance; and
- Accommodation.

Applications can only be made individually by each candidate through www.turkiyeburslari.gov.tr.

About the DEHUKAM Master Program:

This program leads to a graduate master's degree without thesis, for law graduates from a law faculty or other faculties.

The Program will start in mid-September 2020 and end in mid-June 2021 in Ankara, Turkey. Applications must be made on the Website of Ankara University Graduate School of Social Sciences (<http://gradsocialsci.en.ankara.edu.tr>) on the dates specified for the 2020-2021 Academic Calendar.

This program is limited to 30 places. However, this number could be increased depending on the quality of applications received.



Although the program is intended for evening classes, it could also be held during working hours, in particular, to facilitate the participation of faculty members from abroad.

Academic Requirements:

1. To qualify for the program applicants must have obtained a diploma from a four-year undergraduate program of a recognized university and have a GPA of at least 2.00 / 4.00.
2. Since all lectures in the program will be held in English, a minimum of TOEFL IBT 72/CAE C or CPE C score must have been obtained for international students.
